- 1. The Amwell Valley Hounds, Friends of Amwell Valley Hounds and any landowners or other persons making property available for the Amwell Valley Hounds (referred to herin as the "Hosts") give permission at various times for individuals and teams to participate in equestrian activities on the properties owned or operated by one or more of the Hosts.
- 2. For the purposes of this document, the term "equestrian activities" shall include, but not be limited to, participation in organized hunter paces, loading and unloading of horses, transportation of horses on the Hosts' properties, cooling, warming, tacking and grooming of horses, and all equine animal activities as defined by N.J.S.A. 5:15-2.
- 3. The undersigned (herein referred to as "I" or "Me" or "Participant" is either 1) an adult participating in the equestrian activity, or 2) an adult acting in loco parentis for a minor, pursuant to N.J.S.A. 5:15-8, who has assessed and approved the conditions and riding ability of the participating minor and has made the decision that the minor should participate in the equestrian activity.
- 4. Participant has been given permission by one or more of the Hosts to enter on the premises to participate in equestrian activities.
- 5. In consideration of receiving permission from the Hosts to enter upon the premises to participate in any equestrian activity, I hereby acknowledge receipt of such permission, and I hereby release the Hosts and their respective officers, directors, employees, agents, contractors, heirs and assigns from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of, or related to, any loss, damage, disease or injury, including death, that may be sustained by myself or the minor child or my property, while on the premises.
- 6. I am signing and executing this document with the full knowledge that equestrian activities are dangerous, that participation in equestrian activities may result in harm or injury to participants, spectators, and property, and with full knowledge of the risks and hazards of entering the premises to participate in equestrian activities. I acknowledge that the Hosts have offered me the opportunity to inspect the premises, and whether I have inspected the premises personally or through an agent, or I have voluntarily chosen not to inspect the premises, I am satisfied and agree that the premises are in a safe condition for the equestrian activity in which I am to participate. I voluntarily assume all risk of loss, damage or injury, including death, to me or my property while I or my property are on the premises.
- 7. In the event I am injured, ambulance service and medical or paramedical attention may be provided by the Hosts. This release extends to any and all liability arising out of or in any way connected with such provision of ambulance and medical or paramedical attention or the failure to provide thereof. I specifically release the Hosts from any duty they may have to provide me with ambulance services and medical or paramedical attention during the equestrian activities in which I am participating.
- 8. I hereby indemnify the Hosts against, and hold the Hosts harmless from, liability for any injury, liability for any communicable diseases, including death, which may be sustained or contracted on the premises by any employee, groom or guest of mine, under age of 18 whom I have brought with me or who has come with me on to the premises in relation to equestrian activities.
- 9. This release shall be binding upon the heirs, distributees, next of kin, executors, personal representatives, and administratos of the undersigned.
- 10. I state and represent to the Hosts that 1) I have read this entire document, and have either discussed the contents of this document with legal counsel or have voluntarily signed it without consulting legal counsel and 2) I am 18 years of age or older and am of sound mind.
