**Requirements:** Bring your own shells (steel shot is requested), and eye and ear protection. A limited supply of 12 and 20 gauge shells will be available for purchase.

### **Rules & Regulations**

- All participants **MUST** sign a Waiver of Liability form.
- Parent/Guardian must sign Waiver of Liability for anyone under the age of 18.
- Break-action shotguns only.
- Teams/groups of 3-5 persons will rotate through the course. Single shooters will be teamed at the event.
- Protective shooting glasses and ear protection should be worn at all times.
- The only time a shotgun will be loaded is when the shooter is actually at the stand preparing to shoot. At all other times the gun will be unloaded and placed in a rack or unloaded and carried with the action open.
- At no time will a shooter load more than two shells in a shotgun.
- Before leaving the stand, shooters will ensure that the shotgun is unloaded and the action is open.
- No alcoholic beverages are allowed on the shooting course or while the participating in the shooting event.
- It is strictly forbidden to shoot at any live bird or animal on any field.
- Failure to comply with safety regulations will result in forfeit of participation.

As in all clay target shooting sports, there is the possibility of pellet deflection off trees, targets, and other solid objects on the shooting course. Likewise pieces of clay targets (and even whole targets) may fall near or even strike the shooter. For all of these reasons, Amwell Valley Hounds requires the use of protective shooting glasses and ear protection.

### **Waiver and Hold Harmless Agreement**

1. I understand the inherent risks involved in recreational sport shooting, and by my signature, I hereby RELEASE, WAIVE, DISCHARGE, and HOLD HARMLESS, Amwell Valley Hounds INC., Amwell Valley Hounds, INC. officers, members and volunteers, Joe and Jill Rossi (property owner), Bill Kelsey (equipment supplier) (hereinafter referred to as ORGANIZATION) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by my person, or to any property belonging to me, while participating in the Amwell Valley Hounds Sporting Clays Fundraiser (hereinafter referred to as the EVENT).

It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assignees and personal representatives, if I am not alive, and shall be deemed as a RELEASE, WAIVER, AND DISCHARGE of the above named ORGANIZATION and PROPERTY OWNER and EQUIPMENT SUPPLIER. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the United States of America.
